NOTICE is hereby given that Devon County Council has made the above titled order.

On **SATURDAY 5 SEPTEMBER 2026**
for a maximum of 1 day
Anticipated Finish **SATURDAY 5 SEPTEMBER 2026**

Between the hours of **08:00** and **18:00**

No person shall cause or permit any vehicle to proceed on the sections of Affected Roads.

Roads affected - **CHURCH HILL, LOVE LANE, MARLDON**

The alternative route for vehicles will be signed on the day.

No person shall except with permission of a Police Officer in uniform or Civil Enforcement Officer cause or permit any vehicle to park, wait, load or unload at any time on the sections of affected roads.

Roads affected -: **MARLDON CROSS HILL**, east side entire length; **MEADOW PARK** north side from Peters Crescent to Vicarage Hill; **MILLMANS ROAD**, south side for the entire length; **PETERS CRESCENT** north side from Millmans Road to Parkfield Close; **VICARAGE HILL** east side from Parkfield Close to Five Lanes Roundabout and **VILLAGE ROAD** west side for entire length.

Introduce a one-way flow of traffic on **VILLAGE ROAD AND LOVE LANE NORTHWARDS FROM IPPLEPEN ROAD TO HULSTERCOMBE LINHAY TO LOVELANE FARM; HULSTERCOMBE LINHAY TO LOVELANE FARM SOUTHWARDS FROM THE JUNCTION WITH COMPTON TO HULSTERCOMBE LINHAY TO PARKFIELD CLOSE; PARKFIELD CLOSE WESTWARDS, FROM VICARAGE HILL TO MILLMANS ROAD; MILLMANS ROAD WESTWARDS, FROM PARKFIELD CLOSE TO MARLDON CROSS HILL.**

No person shall except with permission of a Police Officer in uniform or Civil Enforcement Officer cause or permit any vehicle to make a right turn: from **MARLDON CROSS HILL INTO MILLMANS ROAD; FROM CHURCH HILL INTO VILLAGE ROAD; FROM COMPTON TO HULSTERCOMBE LINHAY INTO LOVE LANE; FROM MARLDON HOUSE TO MONKSHAVEN INTO HULSTERCOMBE LINHAY TO LOVELANE FARM; FROM PETERS CRESCENT INTO MILLMANS ROAD AND FROM PETERS CRESCENT INTO PARKFIELD CLOSE.**

No person shall except with permission of a Police Officer in uniform or Civil Enforcement Officer cause or permit any vehicle to make a left turn: from **PARKFIELD CLOSE INTO MILLMANS ROAD; AND FROM MEADOW PARK INTO THE LENGTH OF MEADOW PARK BETWEEN PETERS CRESCENT AND VICARAGE HILL.**
